Questions and Answers:

- Q. Will the contractor be responsible for installing new thermostats to be part of the estimate for the HVAC System bid, or we are going to use the thermostat that's already there.
 - A. Yes, the contractors are required to install new non-programmable thermostats with digital display
- Q. Some of these questions were necessary to be answered by or right after June 21, and they were not, therefore, these questions do affect pricing. I would like to know if the bid date can be extended, and these questions answered.
 - A. Yes, please see above.

Durning the walkthrough with some of the contractors at Fischer III and Florida here are some of the answers.

- Florida: 1 Story units have sideway units in the attic
- Florida: 2 Stories Units have two HVAC units one upstairs in the attic and one downstairs by the kitchen.
- Florida: 2 Stories suction line is 5/8 so Florida needs a 2.5-ton unit instead of 3-ton unit
- Florida's HVAC unit's condenser cage needs to be put back or refitted to secure the units.
- Fischer all units have one HVAC system the air handlers are either in the kitchen or upstairs in the hallway
- Fischer should be 3-ton units
- Thermostat and Drip Pans for all units are to be replaced
- All units are to be replaced with Carrier Air Conditioning systems

I have also attached the updated addresses for the HVAC replacement. The total units are 23 units instead of 28 units, five (5) units have been replaced at Fischer.
