The Contractor(s) shall furnish sufficient organization, equipment and supplies, qualified personnel and management staff with the necessary skill and judgment to perform an initial one-time cut, and subsequent bi-weekly maintenance cuts to the vacant HANO properties specified in the RFQu. It is anticipated that multiple contracts may be issued resulting from this RFQu.
